 - d. Overall supervisory structure anticipated.

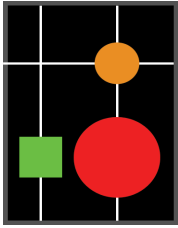

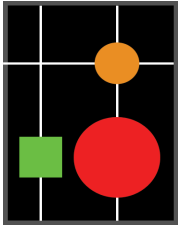

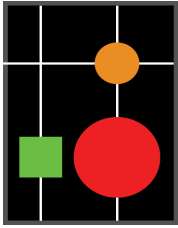
