The Port of Beaumont Navigation District of Jefferson County, Texas, will conduct a Special Meeting on Wednesday, June 2, 2021 at 10:00 a.m., located at The Port District Building, 1225 Main Street, Beaumont, Texas, by telephonic meeting to advance the public health goal of limiting face-to-face meetings (also called “social distancing”) to slow the spread of the coronavirus (COVID-19). There will be no public access to the location above.

All portions of the Meeting shall be Open, unless a Closed Meeting is held when permitted, and in the manner specified, by the Act. If the Act permits all or any portion of the Deliberation of an Agenda item to be Closed, the Governing Body may enter into a Closed Meeting whether or not the Agenda item below states that a Closed Meeting for such item is anticipated. Agenda items are not required to be considered in the same order as listed in the Agenda. Any Agenda item(s) may be tabled for Deliberation at a later Meeting, or removed from the Agenda. Any such tabled or removed Agenda item may be placed on an Agenda for a later Meeting for which Notice has been given and posted pursuant to the Act.
